Preserving Relationships Unlike adversarial courtroom battles, mediation focuses on problem-solving. Since neighbors must continue living together after disputes resolve, maintaining positive relationships is essential. Mediation helps parties find common ground, avoiding the bitter animosity that litigation often creates.

Faster Resolution Court calendars can be backlogged, meaning disputes can drag on for months or years. Mediation can typically be scheduled within weeks, allowing communities to address issues promptly before they escalate.

Flexible Solutions Courts are limited to legal remedies, but mediators can craft creative solutions tailored to meet the parties' needs. Whether addressing noise complaints, architectural disputes or assessment disagreements, mediation allows for innovative compromises that satisfy all parties involved.

For HOA and condominium disputes, mediation offers a practical, relationshippreserving alternative that serves the long-term interests of the entire community while delivering faster, more affordable resolutions.
